### *Unattached Swimmer Process*

The Swim Ontario Board of Director's passed the following motion regarding unattached swimmers at their September 21, 2007 meeting.

An Ontario swimmer may only retain the designation unattached for a period of 30 consecutive days in any given swim season (Sept. 1 – Aug. 31) – in addition the swimmer must have a certified coach in good standing, of a member club in good standing, who takes on the "Coach of Record" status for the swimmer during the "unattached" period. A coach may not have more than 2 "unattached" swimmers at any given time unless they are members of the same nuclear family.
